

Metrolink Eccles line rail maintenance works – summer 2016

South Langworthy Road, near Dallas Court/Dakota Avenue **Phase 1**

A major track replacement programme will see the Eccles via MediaCityUK Metrolink line temporarily close from Sunday 26 June. Transport for Greater Manchester has worked with Metrolink's operator and maintainer, MRDL, to time the essential upgrades to coincide with final works at St Peter's Square stop, when fewer people will be travelling due to the summer holiday period.

Eccles line services are expected to resume between Deansgate-Castlefield and MediaCityUK in early August, with the full line reopening at the end of August.

On-highway works will take place at South Langworthy Road, near Dallas Court and Dakota Avenue, from **Monday 11 July for approximately 26 days**.

The work at South Langworthy Road will be in four phases, with each phase taking approximately six days (**please note, all dates are subject to change**). A one-way system will be in operation during some phases, with signed diversion routes in place, while temporary traffic lights will be in place during other phases to allow for safe working and management of traffic on the highway.






During **phase 1**, the southbound carriageway of South Langworthy Road will be closed travelling towards Broadway from Dakota Avenue, with one-way access travelling from Broadway northbound.

Two signed diversion routes will be in place during this phase:

- **For traffic travelling west along Eccles New Road, in the direction of Eccles town centre:**
via Eccles New Road, James Corbett Road, Daniel Adamson Road and Broadway.
- **For traffic travelling east along Eccles New Road, in the direction of Regent Road roundabout:**
via Eccles New Road, Regent Road roundabout, Trafford Road and Broadway.

All traffic, including HGVs and delivery vehicles, should use these diversions. Access will be maintained during the works.

During **phase 2**, the northbound carriageway of South Langworthy Road will be closed at the junction with Broadway up to Dallas Court. There will be one-way access travelling southbound along South Langworthy Road between Dallas Court and Broadway.

Two signed diversion routes will be in place during this phase:

- **For traffic travelling west along Broadway, towards the Manchester Ship Canal:**
via Broadway, Daniel Adamson Road, James Corbett Road and Eccles New Road.
- **For traffic travelling east along Broadway, towards The Quays:**
via Broadway, Regent Road roundabout and Eccles New Road.

All traffic, including HGVs and delivery vehicles, should use these diversions. Access will be maintained during the works.

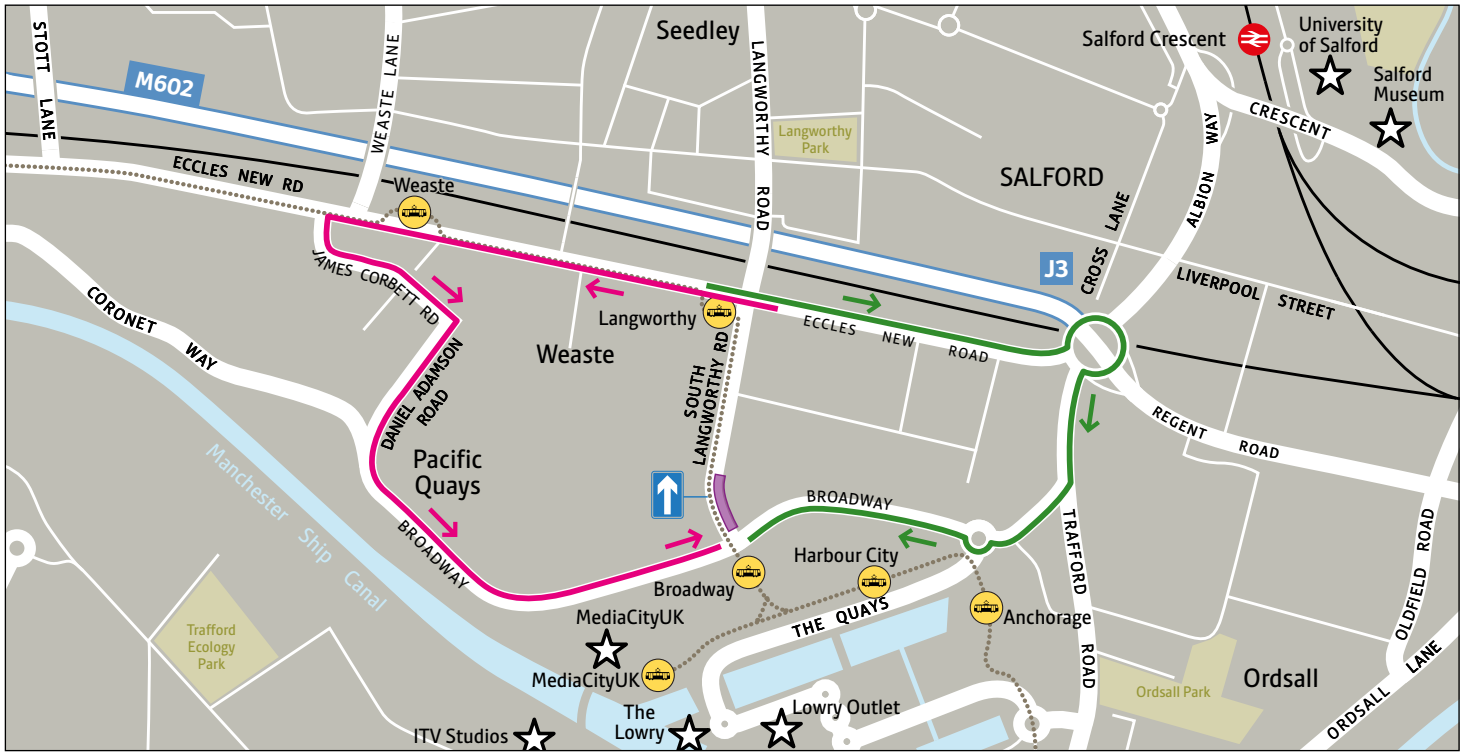

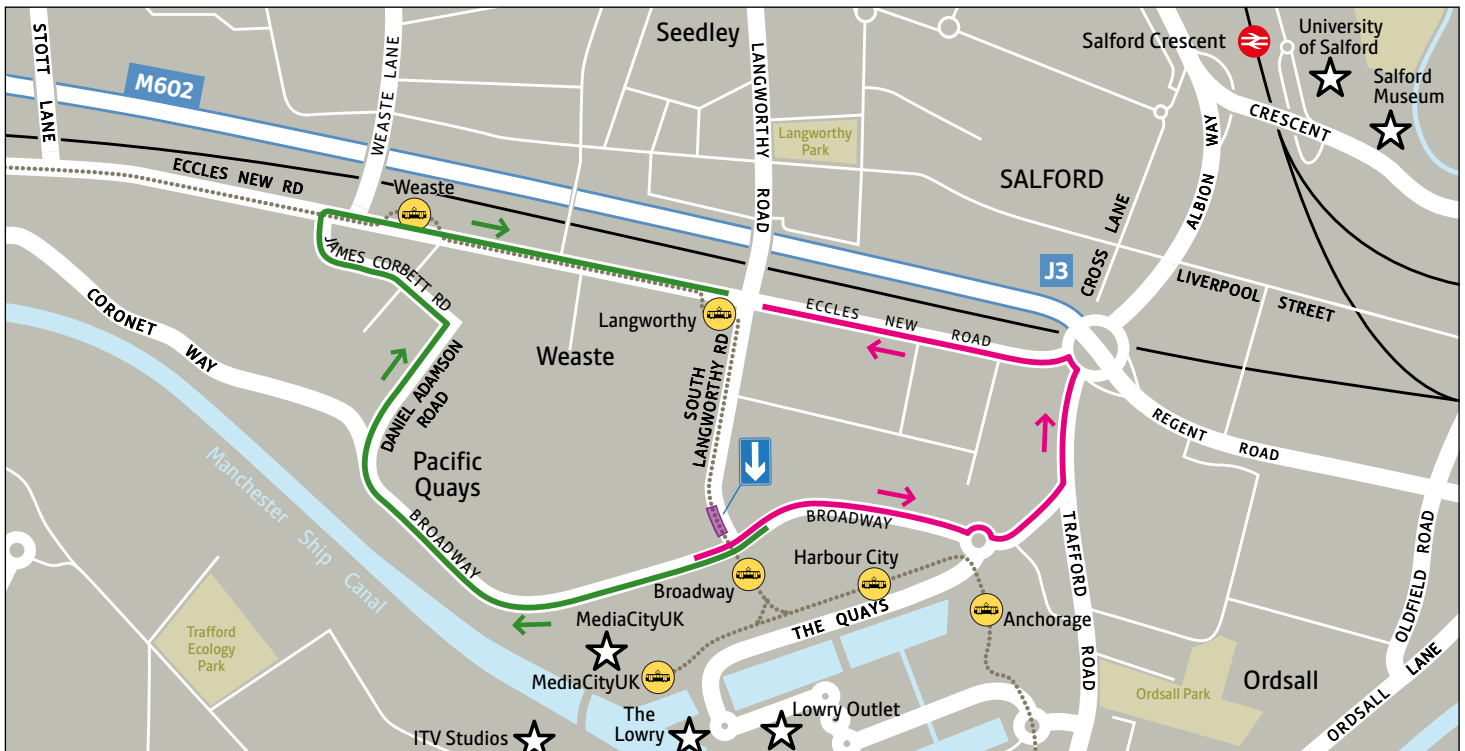
